




# Active Belfast Grant Scheme 2016/17

### **Self-Assessment Form**

Closing date: 12 noon, Monday 7 March 2016



Active Belfast is calling on community, voluntary, statutory and private organisations across Belfast to apply for funding through the Active Belfast Grant Scheme 2016/17.

If you have an innovative and sustainable project which encompasses partnership working and enables more people in Belfast to be physically active and eat more healthily, you may be eligible for a large citywide grant of £26,000 or a small grant of £11,000.

If your organisation can answer YES to ALL of the questions on the self-assessment form, the Active Belfast team will issue an electronic copy of the application form and guidelines to the email address provided.

### Categories for funding:

- Active Travel To increase the number of people cycling/walking throughout the city and encourage healthy eating.
- Active Neighbourhoods Utilising resources within local communities such as places, equipment or people to allow more individuals to be physically active and to eat more healthily.

### Active Belfast Grants will not cover projects which involve:

- Applications from individuals
- Activities promoting political and religious beliefs; this does not preclude
   Faith Community Groups applying for activities related to the aims of the scheme
- Groups or travel outside Belfast City Council boundaries

- Existing projects or one-off events
- Funding to set up a new club
- General running costs which are not related to the specific project for which funding is sought to include endowments/loan payments
- Costs already incurred (retrospective funding)
- Donations (to individuals, groups or charities)
- Fundraising events or activities
- Projects indicating a disproportionate cost for transport
- Management costs of more than 15% of overall grant awarded
- Affiliation or professional membership fees.

Please note: Previously funded organisations who did not submit quarterly monitoring returns and end of project evaluation reports are not eligible for application.
